All Section 8 Housing Choice Voucher Landlords and Participants

Following guidance from the CDC and local/state government, the Housing Authority of Monroe County is implementing the following temporary measures to help prevent the spread of the COVID-19. These temporary measures are necessary to prioritize the safety of our staff, participants, and community members but may cause some delay in services.

- Voluntary moves are suspended until further notice. <u>https://www.hud.gov/sites/dfiles/PIH/documents/COVID19_FAQ_PIH_3-30-20.pdf</u> Emergency moves e.g. Domestic, Fire, Homeless situations etc. will be evaluated on a case by case bases.
- 2. Upcoming May, June, July 2020 Annual Re-examinations are placed on a temporary biennial inspection policy. <u>24 CFR 982.405</u>

Re-examinations for May, June, July and possibly August will be conducted in 2021. Owners are still required to ensure the units are in a safe, decent and sanitary condition.

- 3. Inspections will still be conducted by contacting S8 Coordinator, provided the following: <u>24 CFR 982.305</u>
 - a. Inspections **ONLY** for new Leases and Emergency/Special circumstances
 - b. Unit must be unoccupied. If occupied then the tenant/family must remain on the outside during the inspection. If unoccupied, owner/tenant must unlock the unit and remain outside during inspection.
- 4. Reporting Income Changes:
 - a. Use the HAMC link to complete the Self-Certification form and submit to the Housing Specialist http://www.housingauthoritymonroecounty.org/

Families participating in the HCV program must continue to abide by the terms of their Voucher and lease agreement. HCV participants must continue to:

- Pay their portion of the rent on time and abide by the terms of their lease
- Comply with reexamination processing and reporting requirements by supplying documentation in accordance with the Statement of Family Obligations and their Voucher.
- Complete critical participant functions via email, mail or fax, e.g. Recertification's, Report Change in Family Circumstances and Submit Documentation.
