Garden St

700' of 2" PE gas main to be installed. This includes 14 service laterals & 28 meters. Street restoration will be done to Township requirements

Customer Cost - \$221,762

Commitment must be signed within 30 days and project must begin within 6 months. If agreement is not made within this timeframe, UGI will have to review estimates again to determine if costs have changed.

Avon Court

560' of 2" PE gas main to be installed. This includes 10 service laterals and 10 meters. No final restoration was factored into this, as it is located on private property.

Customer Cost - \$134,560

Commitment must be signed within 30 days and project must begin within 6 months to honor these prices. If agreement is not signed within this timeframe, UGI will have to review estimates again to determine if costs have changed.

Hawthorne Terrace

1,030' of 4" PE *low pressure* gas main to be installed. This includes 14 service laterals & 28 meters. Street restoration will be done to Township requirements.

Customer Cost - \$336,470

Commitment must be signed within 30 days and project must begin within 6 months to honor these prices. If agreement is not signed within this timeframe, UGI will have to review estimates again to determine if costs have changed.

Normal/Hill/Taylor

1,600' of 4" PE *low pressure* gas main to be installed. This includes 30 service laterals and 60 meters. Street restoration will be done to Township requirements.

*Please note that there is an option to tie into a medium pressure distribution line approximately 900' away. Due to the additional footage, the cost is higher. Both options are outlined below. The existing meter for this development is being fed off the low-pressure system. Medium pressure might be considered for future use of generators or additional load.

Low Pressure Customer Cost – \$416,377 Medium Pressure Customer Cost - \$637,105

Commitment must be signed within 30 days and project must begin within 6 months to honor these prices. If agreement is not signed within this timeframe, UGI will have to review estimates again to determine if costs have changed.
